## RATES

### MEDIATION

Sarah offers mediation in two standard formats to accommodate both focused disputes and more complex matters requiring additional time.

**4-Hour Mediation** - \$4,000 total fee, divided equally between parties

**Full-Day Mediation** - \$8,000 total fee, divided equally between parties

**Additional Time** - \$500 per hour, allocated as appropriate among the parties

### ARBITRATION

Arbitration services are available for both shorter proceedings and full-day hearings, with fee structure based on the anticipated scope and duration of the matter.

**4-Hour Arbitration** - \$4,000 total fee, divided equally between parties

**Full-Day Arbitration** - \$8,000 total fee, divided equally between parties

**Additional Time / Review Time** - \$500 per hour

## BILLING & SCHEDULING DETAILS

Sessions are confirmed through my office upon receipt of the necessary scheduling information. Invoices are issued in advance of the scheduled session and are expected to be resolved prior to the mediation or arbitration.

Cancellations or postponements within seven business days of a scheduled session may result in the full session fee. Matters involving unique scheduling needs, multi-day proceedings, or special circumstances can be coordinated directly through my office.
